



## **Roscoe Pound Summer Fellowship**

### **OVERVIEW and DETAILS**

The Pound Civil Justice Institute, a legal, educational non-profit think tank, offers a Roscoe Pound Summer Fellowship (“Pound Fellowship”). The Fellowship is a paid 8-week internship in Washington, D.C. where students will conduct research on topics relating to the civil justice system, will have practical experience in plaintiffs’ law, and will travel to the annual convention of the American Association for Justice in Boston (July 21-25, 2017). The Pound Fellowship provides a \$5,000 stipend and is open to law school students of any level.

The Fellowship seeks to honor the work of Roscoe Pound, Dean of Harvard Law School from 1916 to 1936 and one of America’s great legal thinkers, by providing an opportunity for law students to experience first-hand the important work of plaintiffs’ law, and the importance of an accessible civil justice system.

## **Roscoe Pound Summer Fellowship**

### **REQUIREMENTS and ELIGIBILITY**

- 1. This Fellowship is open to any level law school student.**
  - a. Full-time or part-time law students:** You are eligible if you are currently attending an accredited U.S. law school and have completed at least one full semester by the application deadline.
  
- 2. Applicants will be required to work on-site in Washington, D.C.**
  - a.** Applicants will split their time between the Pound Civil Justice Institute's offices and specific law firm offices in Washington, D.C.
  
- 3. Applicants should commit to working 30 hours per week for a minimum of 8 consecutive weeks.**
  - a.** Start date is negotiable. However, applicants must be available to travel to Boston on July 21-25, 2017.
  
- 4. Factors for consideration in awarding the Pound Fellowship:**
  - a.** Applicants must demonstrate a dedication to the principles of access to the civil justice system. Interest is shown by:
    - i. Volunteer and/or paid work experience.
    - ii. Participation in student organizations.
  - b.** Other factors that will be considered include:
    - i. Your commitment and intentions as demonstrated in the personal statement.
  - c.** Academic achievement

- II. Why are you interested in obtaining a summer position with the Pound Civil Justice Institute? Please explain your goals.
- III. What sort of impact do you think plaintiffs' law has on the greater legal system, and on consumer and civil rights?
- IV. If applicable, select an example of plaintiff's work that you have participated in previously and explain its significance. Alternately, select a civil action that is meaningful to you, and explain why.
- V. Please provide any other information you think we would find useful.
